Context: This workshop will help practitioners to implement the changes in legislation for young carers and their families outlined in the Care Act 2014 and the Children and Families Act 2014. Both pieces of legislation, together with accompanying regulations and guidance, promote a whole family approach. It is especially important to ensure that there is 'no wrong door' for young carers and that whoever or however a family in need comes into contact with an agency, that a common approach and pathway is followed so as to ensure young people are protected from caring roles that impact upon their life chances. This workshop will help you to consider how best to uphold these legal rights for families and how you, in your role, can take a more 'whole family' approach so as to ensure a stable environment for young carers as well as adult carers and the cared for person.

This workshop provides staff with the opportunity to build on their basic understanding of carer and whole family working issues. Ideally those attending should have either attended the Because Carers Count Programme (Training@actionforcarers.org.uk) and/or have completed the e-learning "Carer Aware" Course (http://surreycc.elumos.net/public/)
